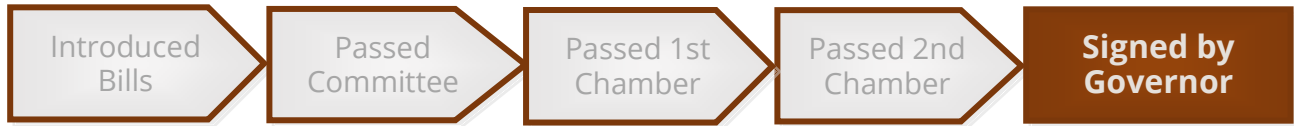

SUMMARY: Requires coverage for dependents under the age of 26. Passed in House (6/28/2023; To Insurance and Financial Services Committee). Enrolled in House (10/10/2023). Passed in Senate (10/10/2023; 23-14).

HB 4622 Health Insurers (Miller)

SUMMARY: Prohibits annual and lifetime dollar limits.

SUMMARY: Repeals provision related to publication of cures for conceptive preventatives.

SB 67 Criminal Sexual Conduct (Lauwers)

SUMMARY: Prohibits sexual contact and sexual penetration under pretext of medical treatment and provides penalties.

SB 68 Criminal Sexual Conduct (Geiss)

SUMMARY: Modifies sentencing guidelines for sexual contact or sexual penetration under pretext of medical treatment.

SB 69 Health Professionals (Theis)

SUMMARY: Requires additional individual present during certain examinations of minors under certain circumstances and require consent.

SB 70 Health Professionals (Johnson, R.)

SUMMARY: Enacts sentencing guidelines for the crime of performing certain medical treatments on a minor without consent and another individual present.

SB 71 Medical Records (Hauck)

SUMMARY: Implements provision for the protection, retention, and maintenance of medical records referencing a vaginal or anal penetration treatment for 15 years by a health professional and health facility or agency and requires certain boards to provide guidance to licensees on medical services involving vaginal or anal penetration.

SB 72 (PA 63) Criminal Procedure (McDonald Rivet)

SUMMARY: Enacts sentencing guidelines for the crime of intentionally failing to document certain services in a medical record.

SB 79 Firearms/Weapons (Bayer)

SUMMARY: Provides penalties for storing or leaving a firearm where it may be accessed by a minor.

SUMMARY: Modifies definitions.

SUMMARY: Requires screening minors for lead poisoning at intervals determined by the department of health and human services by rule and requires documentation of screening in certificate of immunization.

SB 356 Health Insurers (Hertel, K.)

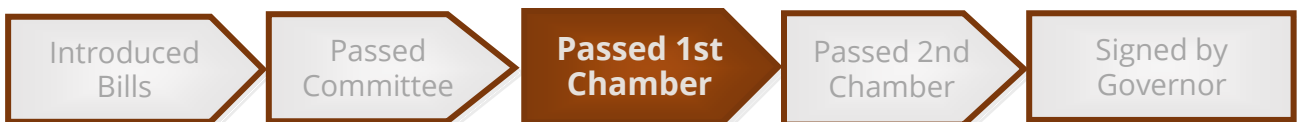

SUMMARY: Allows governmental agency and employee liability for criminal sexual conduct.

HB 4487 Criminal Sexual Conduct (Scott)

SUMMARY: Provides exception to notice requirements for civil actions for criminal sexual conduct filed in the court of claims.

SUMMARY: Requires coverage for certain prenatal screenings.

HB 5167 Blood Pressure Monitors (Neeley)

SUMMARY: Provides coverage for blood pressure monitors for pregnant or postpartum individuals.

ACTIVITY: Passed in House (6/26/2024; 101-8; Given Immediate Effect; Earlier advanced to Third Reading with committee substitute H-1 adopted); Received in Senate (6/26/2024; To Health Policy Committee)

HB 5168 Blood Pressure Monitors (Edwards)

SUMMARY: Provides coverage for blood pressure monitors for pregnant or postpartum individuals.

ACTIVITY: Passed in House (6/26/2024; 89-20; Given Immediate Effect; Earlier advanced to Third Reading with committee substitute H-1 adopted); Received in Senate (6/26/2024; To Health Policy Committee)

HB 5169 Health Screenings (Hood)

SUMMARY: Provides mental health screenings and resources for mothers during certain time periods.

HB 5170 Mental Health Screening (Carter, B.)

SUMMARY: Requires coverage for mental health screenings for new mothers.

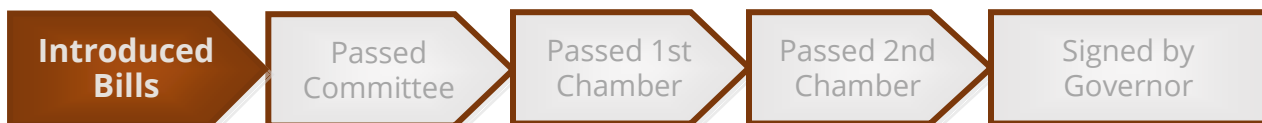
