Repeals penalty for administering with intent to procure miscarriage. Introduced (1/12/2023; To Judiciary Committee) Signed by the Governor (4/5/2023; Signed April 5, 2023; Effective date: 90 days after the sine die adjournment of the Legislature)

# HB 4032 Abortion (Young)

Removes reference to crime of administering drugs to procure miscarriage to reflect repeal. Introduced (1/18/2023; To Judiciary Committee) Signed by the Governor (4/5/2023; Signed: April 5, 2023, Eff: 90 days after the sine die adjournment of the Legislature)

# HB 4219 (PA 24) Michigan Strategic Fund (Hall)

# HB 4200 Lead Poisoning (Scott)

Requires screening minors for lead poisoning at intervals determined by the department of health and human services by rule and requires documentation of screening in certificate of immunization. Reported in House (6/27/2023; Substitute H-1 adopted at previous meeting; By Health Policy Committee). Signed by the Governor (10/3/2023; Signed: October 3, 2023, Effective: October 3, 2023)

# HB 4619 Insurers (Rogers)

Prohibits denying coverage based on gender, gender identity, or sexual orientation or expression. Passed in House (6/28/2023; To Insurance and Financial Services Committee). Enrolled in House (10/10/2023). Passed in Senate (10/10/2023; 23-15). Signed by the Governor (10/19/2023; Signed: October 19, 2023, Effective: 90 days after sine die)

# HB 4620 Health Insurers (Edwards)

Prohibits denying coverage for preexisting conditions and prohibits canceling coverage based on health of insured. Passed in House (6/28/2023; To Insurance and Financial Services Committee). Passed in Senate (10/10/2023; 25-13; Earlier committee substitute S-1 adopted). Signed by the Governor (10/19/2023; Signed: October 19, 2023, Effective: 90 days after sine die)

# HB 4621 Health Insurers (Fitzgerald)

Requires coverage for dependents under the age of 26. Passed in House (6/28/2023; To Insurance and Financial Services Committee). Enrolled in House (10/10/2023). Passed in Senate (10/10/2023; 23-14). Signed by the Governor (10/19/2023; Signed: October 19, 2023, Effective: 90 days after sine die)

# HB 4622 Health Insurers (Miller)

Prohibits annual and lifetime dollar limits. I Passed in House (6/28/2023; To Insurance and Financial Services Committee). Enrolled in House (10/10/2023). Passed in Senate (10/10/2023; 21-17). Signed by the Governor (10/19/2023; Signed: October 19, 2023, Effective: 90 days after sine die)



# HB 4623 Health Insurers (Koleszar)

Provides minimum required coverage. Passed in House (6/28/2023; To Insurance and Financial Services Committee). Enrolled in House (10/10/2023). Passed in Senate (10/10/2023; 20-18). Signed by the Governor (10/19/2023; Signed: October 19, 2023, Effective: 90 days after sine die)

# HB 4071 Chemotherapy (Steckloff)

Provides equal treatment for coverage for orally administered anticancer chemotherapy. Introduced (2/2/2023; To Health Policy Committee). Reported in Senate (10/4/2023; Substitute S-1 adopted; By Health Policy Committee). Presented in House (10/17/2023; Presented 10/17/2023)

# HB 4945 Sentencing Guidelines (O'Neal)

Updates sentencing guidelines. Committee Hearing in House Criminal Justice Committee (9/26/2023). Reported in House (10/3/2023; By Criminal Justice Committee). Received in Senate (11/2/2023; To Session). Signed by the Governor (11/20/2023; Signed: November 20, 2023, Effective: February 13, 2024)

# HB 4276 Pharmacy Benefit Managers (Farhat)

Regulates Medicaid managed care contract with pharmacy benefit managers, and requires reporting. Introduced (3/14/2023; To Health Policy Committee). Reported in House Health Policy Committee (10/19/2023; H3 sub adopted). Received in Senate (10/31/2023; To Health Policy Committee). Enrolled in House (11/9/2023). Passed in Senate (11/9/2023; 36-0; Earlier discharged from the Health Policy Committee and advanced to Third Reading). Signed by the Governor (12/8/2023; Signed: December 7, 2023, Effective: February 13, 2024)

# HB 4949 Abortion (Pohutsky)

Creates reproductive health act. Reported in House (9/20/2023; By Health Policy Committee). Received in Senate (11/2/2023). Enrolled in House (11/8/2023). Signed by the Governor (12/11/2023; Signed: December 11, 2023, Effective: February 13, 2024)

# HB 4951 Abortion (Hope)

Amends sentencing guidelines and other references to certain abortion crimes to reflect repeal. Introduced (9/7/2023; To Health Policy Committee). Received in Senate (11/2/2023; To Session). Enrolled in House (11/8/2023). Signed by the Governor (11/22/2023; Signed: November 21, 2023, Effective: February 13, 2024)

# HB 4953 Abortion (Morse)

Revises revised judicature act of 1961 to reflect repealed abortion laws. Introduced (9/7/2023; To Health Policy Committee). Received in Senate (11/2/2023; To Session). Enrolled in House (11/8/2023). Signed by the Governor (11/22/2023; Signed: November 21, 2023, Effective: February 13, 2024)

#### HB 4954 Abortion (Brabec)

Modifies the state school aid act of 1979 to reflect repealed abortion laws. Introduced (9/7/2023; To Health Policy Committee). Received in Senate (11/2/2023; To Session). Enrolled in House (11/8/2023). Signed by the Governor (11/22/2023; Signed: November 21, 2023, Effective: February 13, 2024)

# HB 4955 Abortion (Price)

Revises occupational code to reflect repealed abortion laws. Introduced (9/7/2023; To Health Policy Committee). Received in Senate (11/2/2023; To Session). Enrolled in House (11/8/2023). Signed by the Governor (11/22/2023; Signed: November 21, 2023, Effective: February 13, 2024)

# HB 4956 Abortion (Rogers)

Removes reference to crime of partial birth abortion to reflect repeal. Introduced (9/7/2023; To Health Policy Committee). Received in Senate (11/2/2023; To Session). Enrolled in House (11/8/2023). Signed by the Governor (11/22/2023; Signed: November 21, 2023, Effective: February 13, 2024)

# **<u>SB 71</u>** (PA 62) Medical Records (Hauck)
