Title: Inclusion of Intersectional Education Regarding LGBTQIA+ Patients for Medical Students, Family Medicine Residents and Family Physicians

RESOLVED, That the Michigan Academy of Family Physicians support implementation of a LGBTQIA+-centered education opportunity for medical students, family medicine residents and family physicians. This education shall include the intersection of LGBTQIA+ and BIPOC communities.

RESOLVED, That the Michigan Academy of Family Physicians formally states its opposition to any restrictions to funding for undergraduate and graduate medical education based upon the provision of education or care for LGBTQIA+ communities.

RESOLVED, That the Michigan Academy of Family Physicians creates and implements a value-based payment survey to gauge Michigan members' perceptions and attitudes with respect to value-based payment models and return-on-investment, and be it further

RESOLVED, That the Michigan Academy of Family Physicians requests the American Academy of Family Physicians develop transparent data and return-on-investment information on value-based payments for distribution to Family Physicians.

Title: Preserve Private Practice Primary Care with a Strategic Partnership

RESOLVED, That the Michigan Academy of Family Physicians requests the American Academy of Family Physicians to initiate public advocacy in support of the prior to June 2025 Advisory Committee on Immunization Practices structure, including the liaison representative program; and be it

RESOLVED, That the Michigan Academy of Family Physicians requests the American Academy of Family Physicians send a letter to the Secretary of U.S. Department of Health and Human Services calling for an immediate reversal of the recent changes to Advisory Committee on Immunization Practices; and be it

RESOLVED, That the Michigan Academy of Family Physicians requests the American Academy of Family Physicians send a letter to the Senate Committee on Health, Education, Labor and Pensions and request an investigation into the actions of the Secretary of U.S. Department of Health and Human Services regarding his administration of the Centers for Disease Control and Prevention and Advisory Committee on Immunization Practices.

RESOLVED, That the Michigan Academy of Family Physicians requests the American Academy of Family Physicians will, if necessary, identify and solidify alternative evidence-based vaccine advisory structures and vaccine guidelines and invest resources in such initiatives.
